Doping Prevention Plan ICE HOCKEY

since 1.1.2021 the new Anti-Doping Federal Act (ADBG 2021) is in force, which provides for mandatory doping prevention measures in Austrian sports, in addition to some other innovations. In coordination with the Austrian Ice Hockey Federation (ÖEHV) and the Ice Hockey League, a doping prevention plan was developed based on two main pillars:

All members of the national teams (starting with U17) as well as Ice Hockey League clubs - including coaches as well as support staff - are obliged to complete one of the following eLearning courses:

Once the course and the subsequent test have been successfully completed, there is the option of calling up a confirmation (certificate). This does not need to be submitted as the progress is visible in the system anyway. Please note that the certificate is valid for one year. After one year, the system automatically prompts users to complete a knowledge check. If all questions were answered correctly, the certificate will be extended for one year. The course only needs to be (partially) redone if one (or more) questions were answered incorrectly.
